The Shasta County Cattlemen's Association Memorial Youth Lending Program provides no-cost loans to Shasta County Youth who wish to purchase, show, and sell cattle in the Shasta County District Fair. This program was founded in memory of Steve Moller, a long-time member and leader of the Shasta County Cattlemen's Association and a 4-H Beef Leader in Contra Costa County before moving to Shasta County.

Steve was always a proud supporter of local youth who had an interest in agriculture. As a Contra Costa County rancher, Steve would show his support of local youth by "selling" a steer to the them and deferring payment until the steer was sold at the Jr. Livestock Auction. In his memory, this program was created so that Shasta County youth could have the same opportunity.

Since the inception of this program additional contributions have been made honoring past members including Mrs. Virginia Morelli, William Quinn, Glenn Aldridge, Mrs. Mike Moller, and Dr. Magladry.

Memorial Youth Lending Program Agreement

I hereby apply for the Shasta County Cattlemen's Association Youth Lending Program funds in the amount of \$______ to be used for the purchase and care of the animal specified in this application. In order to facilitate approval of my request, I agree to the following terms as follows:

- a. I certify that I am a current grade school or high school student (age 9 or older), and am a current FFA, 4-H, Independent, or Grange member.
- b. I agree to use the advance for the purchase and care of the animal described in the Project Information on this Application.
- c. I agree to care for the animal in accordance with good and acceptable agricultural practices. I understand that the Shasta County Cattlemen's Association has the right to inspect the animal and any facility where the animal is housed.
- d. I agree to sell the animal and remit the proceeds received from the sale of the animal to the Shasta County Cattlemen's Association in an amount equal to the amount advanced to me within 14-days of sale, or within 7-days of student's recipient of proceeds whichever is sooner. To assure that the Shasta County Cattlemen's Association will receive the proceeds, I authorize them to notify any and all parties deemed necessary that I have agreed to remit the proceeds to the Shasta County Cattlemen's Association. I understand that even if I don't sell the animal, I will still be obligated to repay the Shasta County Cattlemen's Association within 12 months of the application date.
- e. I agree to post Shasta County Cattlemen's Association signage in my animal space at the Shasta County Fair and return that signage within 14 days of sale.
- f. I agree to provide a photograph of myself and my animal to the Shasta County Cattlemen's Association within 14 days of sale.
- g. I agree to notify the Shasta County Cattlemen's Association within 10 business days of any material changes in the Project Information.
